Monthly HOA Update:

Improving Community Safety

Earlier this year, the HOA Board began working on the North Gates Safety & Security project with Kevin DeHaan, owner of S & K Security. As of the first week of this month, this project has been 100% completed!

To help keep residents informed about all the important work our HOA Board does, and to elaborate on the benefits of this security project, Kevin DeHaan sat down for an interview for this newsletter.


When asked about the importance of this security system for the Falling Waters community, DeHaan said that this level of security is necessary to improve the safety of our residents. He said our new system, "is designed to have control of all people coming in and out of your community," and that the system monitors "all vehicle traffic via barcode automation and closed circuit television."

The Falling Waters security system consists of barcode automation, mircom technologies for telephone entry and keyless entry, and an LTS security camera system.

These three different types of systems are used throughout the country, and can be found in government facilities, airports, schools, gated communities, and various types of industries. As the Falling Waters community grows, DeHaan said that street cameras can be added to our system to enhance security.

DeHaan shared that he feels this security system is important in our community due to "the constant flow of traffic like contractors." He said that communities like Lakes of the Four Seasons and Schilling have also invested in security systems like this because of the benefits and importance. He shared that the Falling Waters system can read the make, model, and license plate of all vehicles.

DeHaan even provided an example of how this system is already helping our community. He said, "last Saturday I was out at Falling Waters to assist Sherri Cullom (the HOA Board President) in playing back the security video since someone knocked over the South Gate mail box." Thanks to the new system, they were able to determine the time, date, driver, and vehicle make and model involved in this incident, which means that Falling Waters will not have to pay for the mailbox repairs, enabling more funding to go towards additional improvements for the community.



From the Desk of the President

Maintaining active communication with all Falling Waters community members is one of the top priorities of the Falling Waters HOA. To keep residents informed about everything the Board has been up to, HOA Board President Sherri Cullom has put together the following update:

"Our HOA has had a busy year. I am lucky to be surrounded by a strong, volunteer board of directors. We have been able to implement noticeable changes that will help the safety and security of all residents. The board's goal is to improve the collective quality of life in Falling Waters. We live in the community, talk with our neighbors and gather a point of view of what people want. We then attempt to move in that direction, while paying attention to what the governing documents designate, and do our best to try to balance the two.

The front (South) gates are now being closed Mon- Fri and open on Sat and Sunday between 7am to 5 pm. The developer asked for the gates to be open on the weekends to help with lot sales. I would like to thank everyone for their patience as we increase the times that the gates are closed. We have had a lot of visitors having to learn the entry system. The rear (North) gates are now accessible by residents only.

The speed bumps that have been put in also are helping with the speeding problem. These bumps are year round and can be driven over by the snowplows.

There has been an uptick in building. That is great news! It means more neighbors to enjoy our beautiful subdivision.

Important Legal Notice

The Board of Directors of the Falling Waters Conservancy District is inviting candidates for membership on the Board of Directors of the Conservancy District to file nominating petitions pursuant to I.C. 14-33-5-3. Three at large directorship positions will be voted upon at the 2022 annual meeting of the Falling Waters Conservancy District. One position is for a two-year term, one position is for a one-year term, and two are for a four-year term, currently vacant. Interested and qualified applicants for directorship positions are invited to submit a nominating petition signed by at least five (5) freeholders in good standing from the District. A candidate must be a freeholder from the District or the nominee of a corporate freeholder. The nominating petitions must be filed pursuant to the provisions of the Indiana Conservancy Act before December 1, 2021. Nominating petitions can be filed by mailing them to the mailing address of the attorney for the Falling Waters Conservancy District which is P.O. Box 980, Cedar Lake, Indiana 46303. Nominating petitions that are mailed are valid only if delivered or postmarked before December 1, 2021, and if the envelope has sufficient United States Postage and is addressed to the aforementioned address. Please notate which director position (term of years) you are interested in.

To be qualified to hold the position of director, an individual must be qualified by knowledge and experience in matters pertaining to the development of the district. A nominee need not be a petitioner for establishment of the district. A nominee does not have to be a resident of the area of the district from which nominations are invited but must be a freeholder.
